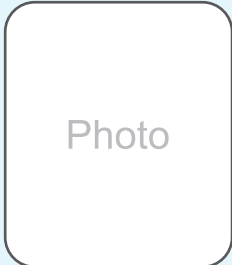

RESIGNATION/TERMINATION/CANCELLATION OF ASSOCIATE SHIP

- Associate can resign as per his/her own will. If he/she intends to rejoin the business, then he/she can join again only after 6 months of such resignation and cannot claim for the business, income and/or downline which was generated on the old ID. In this 6 month period, the Associate will not work and he/she will not be active in the Company's business.

- Company will Buy Back products that are in good condition, usable , resalable , sealed within 30 days of purchase.
- This rule is strictly imposed on all the Business Associate to ensure that the products are purchased keeping in mind the requirement and demand of the product in your area. It is advised that Business Associate should not overstock the products and sponsor should guide his/her downline on purchase ethics.
- Associate should purchase products if 50% of the products in stock have been sold or consume personally. This will help the company to ensure the quality of products and satisfy the Associate.
